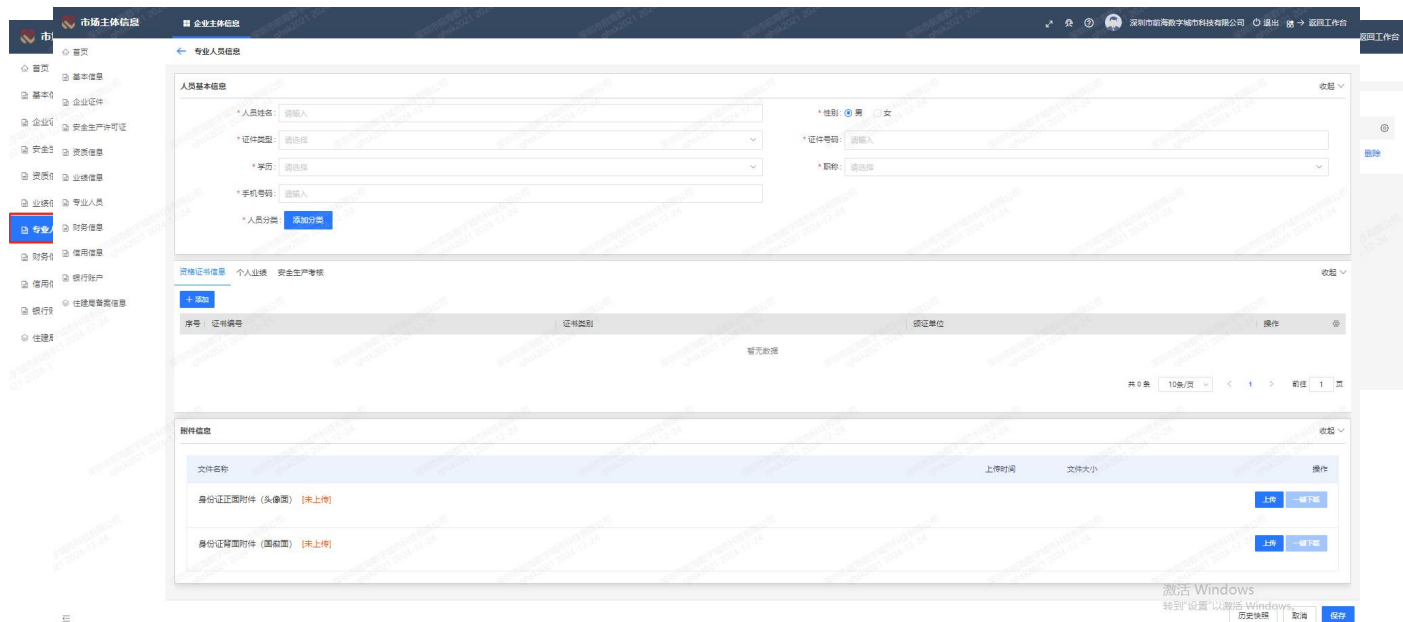

### Prequalification Review Measures

#### 一、资格预审委员会组成

##### I. Composition of the Prequalification Review Committee
